

SILVER DRAGON'S HOARD: SOMETHING TO DO DURING COVID

THIS CONTEST IS FREE TO ENTER. IT IS OPEN ONLY TO RESIDENTS OF CANADA (EXCLUDING RESIDENTS OF QUEBEC) AND IS GOVERNED BY CANADIAN LAW

1. KEY DATES:

Something to do During Covid called (the “**Contest**”) begins on May 31, 2021 at 7:00 p.m. Mountain Time (MT), when a list with a total of twenty (20) tasks will be released on Dragon’s Hoard Entertainment’s Facebook page. The Contest ends on July 15, 2021 at 7:00 p.m. Mountain Time (MT) when we will cease taking submissions. The winners for the contest will officially be confirmed by Dragon’s Hoard Entertainment LTD (the “**Sponsor**”) in accordance with these Official Rules and Regulations (the “**Rules**”), within five (5) business days thereafter.

2. ELIGIBILITY:

Neither the Sponsor, nor any of the other Released Parties, will intervene in any disputes between eligible entrants..

The winners will be announced on Dragon's Hoard Entertainment's Facebook page within five (5) business days of Contest close.
